



LT COL S.J. VAN ZYL – 95752119PE / SANDF (NOTICE IN TERMS OF SECTION 3 OF ACT 40 OF 2002)

1. The above matter as well as our letter dated 20 January 2015, which was served on your offices by hand and forwarded via facsimile on 20 January 2015, refer.
2. We confirm our instructions are that notwithstanding the demands contained in our aforesaid letter, you have failed and/or refused to :
 - 2.1. uplift our client's suspension;
 - 2.2. reinstate him into the South African National Defence Force; and
 - 2.3. provide us with a date on which our client can report for duty.
3. We confirm further that we have not received any answer to our aforesaid letter and at this stage we do not have any indication on whether you intend to comply with our demands, as set out above, or not. We cannot and will not however allow our client to remain prejudiced in this matter and will not hesitate to protect his rights.
4. In the premise our instructions are to proceed with such further legal steps as may be necessary and/or required in the circumstances in order to compel you to uplift our client's suspension, reinstate him into the South African National Defence Force and to provide us with a date on which our client can report for duty. We confirm that we expressly requested, in our above letter, that we receive your **urgent** co-operation herein and in light of your aforesaid failure and/or refusal and the serious impairment of our client's rights, the abovementioned further legal steps may include approaching the High Court on an urgent or semi-urgent basis.
5. We implore you to **urgently** comply with our demands and to provide us with your written confirmation thereof, before close of business of even date hereof, in order to avoid unnecessary and expensive litigation at the expense of the tax payers.
6. We trust you find the above in order and await your **urgent** and immediate response hereto, for which we thank you in anticipation.

7. Insofar as may be necessary, this letter serves as notice of the aforesaid legal proceedings in terms of Section 3 of Act 40 of 2002.
